GENERAL INSTUCTIONS FOR REVALUATION OF ANSWER-PAPER/S

1. As per the University Circular no. VCD/01/2016 all Examinees can apply for the revaluation of the answer book with whatever marks he/she secured & even the zero marks.
2. The candidate should fill up the form for revaluation of answer-paper accompanied with a non refundable fee of Rs. 250/- per paper (for Open category) and Rs. 125/- (for Reserved Category) payable in cash only, along with the certified photocopy of marksheet and copy of question paper. The duly filled in and signed form shall be submitted to the college office. Incomplete application form in any respect shall be rejected without assigning any reason and the fees paid along with the application form shall not be refunded.
3. The change of marks, if any shall be communicated to the applicant/s and revised statement of marks shall be given to him / her only on surrendering of his / her original statement of marks.
4. The whole process of revaluation shall be completed as far as possible within a period of 30 (thirty) working days from the date of the receipt of application for the revaluation of answer paper.
5. Photocopy of re-assessed answer books by the subsequent examiner/s shall in no case be supplied to the examinee.
6. The result of the revaluation of answer book/s shall be binding on the candidate and that he / she shall accept the revised marks assigned to the paper/s.
