Agenda 1: Dr. Mamta Rane read the previous meeting's minutes the same was approved.

Agenda 2: Action Taken Report was read and confirmed.

Agenda 3: The meeting was informed about college receiving Permanent affiliation on 18th January, 2024.

Agenda 4: The meeting was informed that the college secured B+ Grade in the second cycle, as against B grade in the 1st cycle with a total score of 2.56 CGPA. It was also informed that the New Accreditation system is in the line which would be implemented from June 2024.

Agenda 5: It was informed that NEP will be implemented from the academic year 2024-25 for all 1st year courses. But there is not clear picture of NEP so we are waiting for new guidelines from University of Mumbai.
