

OR

Must have passed an examination of another university or body recognised as equivalent to higher secondary school certificate (H.S.C - Std.XII) examination, (Eligibility certificate issued by University of Mumbai to be submitted)

## **RULES FOR CANCELLATION & REFUND**

Students must read the cancellations and refund rules carefully before approaching the college office. As per the University of Mumbai ordinance no O.2859 (A&B) all fees paid at the time of admission shall be refunded on following conditions:

1. All fees paid at the time of admission shall be refunded after deduction of Rs 50/- (Rupees fifty only) as administrative charges if the student informs to the Principal in writing before the commencement of the term that he/she desires to cancel the admission.
2. If a student informs the Principal of the College within 30 days from the date of the commencement of the term that he desires to cancel his/her admission, all fees shall be refunded to him after deduction of Rs. 100/- (Rupees eighty only) as administrative charges.
3. Tuition fees paid by a student at the time of admission shall be refunded after deducting Rs. 150/- (Rupees hundred fifty only) as administrative charges, provided

### **For U.G. Programmes**

The candidates who have taken admission in under graduate courses may request for refund of fees after applying in writing for cancellation of their admission to the course. The refund of fees as applicable shall be made on or before 30<sup>th</sup> day after the date of cancellation and thereafter. The percentage of fee for the course shall be refunded to the candidate after deducting charges as follows:

The total amount considered for the refund of fees from the commencement of academic term of the program includes the following:

I) All the fee items chargeable for one year are as per relevant University circulars for different faculties (excluding the program for which the total amount is fixed by other competent authorities).

II) The fee charged towards group insurance and all fee components to be paid as University share (including Vice-Chancellor fund, University share fund, University fee for sports and cultural activities, E-charge, disaster management fund, exam fee and Enrolment fee) are non-refundable.

III) Fee collected Identify card and Library card, admission form and prospectus, enrollment and any other programme specific fee are not refundable after the commencement of the academic term.

## **For Post Graduate Programmes (Vide University Circular UG/253 of 1996)**

- A.** The registration fees once paid for the PG courses will not be refunded for any reason.
- B.** The Tuition fee paid by the candidate for the course in which he/she is registered as apg students will be refunded to him/her if he/she leaves the said program without attending any lectures, seminars or practical, subject to a deduction of 25% of the tuition fee. The application by the candidate for such refund will only be entertained if it is received by the Principal/ Registrar/ Head of Department within fifteen days of the date of commencement of the lectures of the academic year in which the fees is paid.

## **RULES AND REGULATION**

- Reference books, journals, periodicals, magazines and news papers are allowed for home lending.
- A fine of Rs.5/- will be charged per day after the due date till the book is returned. Kindly note that Sunday and public holidays will also be counted while charging this fine.
- If the book is lost / damaged by the student or if the pages are missing from the book, latest edition of the book should be replaced along with the fine
- Reissue of the book is subject to availability and demand of the same
- Disregard and negligence to these rules will be reported to the principal for appropriate action against the student concerned.

## **DISCIPLINARY RULES & REGULATIONS**

We, the MPAVS Trust and college believe that decency in dress, behaviour and attitude are reflections of a civilized and educated society. Therefore , **we lay special emphasis on decent dress code and discipline norms. Indiscipline and indecency of any nature will be appropriately dealt with, irrespective of gender, caste or creed.** Kindly follow the following rules of the college:

- Students must carry and display their **Valid Identity Card** within the premises of the college and wherever they represent the college. It should be produced whenever demanded by the staff of the college.
- Students are prohibited to loiter in the corridors or within the premises of the college.
- Students behavior should not be detrimental to the reputation of the college, wherever they happen to be.
- Students are directed not to bring any outsiders without the written permissions of the principal.
- Students are not permitted to collect any fund from other students or outsiders.
- Students shall not organize on their own picnics, excursions, trips,etc.
- **Use of cell phone or any kind of communication devices is strictly prohibited within the premises of the college failing which Rs. 500/- will be charged as penalty.**
- **College will not be held responsible for any loss of valuables.**
- Damage to any property in the college premises will be strictly dealt with and the student will be liable to compensate for the same.
- **Students must read the Notice Board daily.**
- Students must approach the Discipline Committee In-charge for any matter related to indiscipline in the college premises
- **RAGGING is a cognizable offence. Any student found guilty will be dealt with strict actions as per the law. Ragging is a cognizable offence as per the notification of the Government of Maharashtra and is strictly prohibited under any circumstances within the premises of the college.**
- Students must co-operate with the staff for smooth functioning of the college.
- **NO OUTSIDE INFLUENCE, POLITICAL OR ANY OTHER DIRECTLY OR INDIRECTLY WOULD BE PERMITTED WITHIN THE PREMISES OF THE COLLEGE.**
- Discipline Committee of the college looks into these matters and student must approach to the Convener of the Committee for forgiveness or for complaints against fellow students if any.
- **Principal's decision relating to disciplinary action will be final.**

## **ATTENDANCE - As per Ordinance No.0.6086 (Attendance for learners)**

- i. As per the rules and regulations of the University of Mumbai, 75% attendance in regular lectures/practical/tutorials of all the subjects is compulsory failing which students would be debarred from appearing in the college examinations.
- ii. Leave of absence is granted only if students are sick or suffering from some serious illness and physically not in a position to attend the lectures. However, this has to be reported to the college authority and application to this effect be submitted to the college inward prior or within 2 days from the date of commencement of leave of absence along with the medical certificate failing which the student will be treated as defaulter.
- iii. List of attendance defaulters would be displayed on the Notice Board of each class. Students must monitor their attendance failing which letter would be issued to Parents about the same and finally debarred from appearing in the examinations on account of shortfall in compulsory 75% attendance.
- iv. Attendance Committee of the College looks into these problems. Students are directed to contact the Convener of the Committee in this regard.

## **RAGGING IS STRICTLY PROHIBITED**

### **THE MAHARASHTRA PROHIBITION OF RAGGING ACT,1999**

Ragging means display of disorderly conduct, during of any act which causes or is likely to cause or is likely to cause physical or psychological harm or raise apprehension or fear or shame or embarrassment to a student in any educational institution and includes:

**I: Teasing, abusing, threatening or playing practical jokes on, or causing hurt to, such student ; or**

**II: Asking a student to do any act or perform something which such student will not, in the ordinary course willingly do.**

### **PENALTY OF RAGGING**

Whoever directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution shall, on conviction, **be punished with dismissal or suspension from the educational institution, imprisonment for a term which may extent to two years and shall also be liable to a fine which may extend to ten thousand rupees.**

### **NOTE:**

1. The student(s) should report the incident of ragging (if any) to the Principal immediately, so that necessary steps can be initiated in the matter.
2. The decision of the Head of the education institution that the student has indulged in ragging shall be final.

## **EXAMINATIONS & RESULTS**

- i. On behalf of the University of Mumbai the College conducts all the examinations during the academic year with the help of the Examination Committee.
- ii. There will be two examinations at the end of each term i.e. First Terminal and Second Terminal Examinations for FY & SYBCom. Each examination will be based on the portion taught as prescribed by the syllabus. Each paper will be of 50 marks with a duration of 2 (two) hours. In case of subjects with projects/tutorials, 10 marks will be allotted for the same and theory marks will be converted accordingly as per the norm.
- iii. Similarly, in case of the Semester Pattern of examinations for BCAF and BCBI, the college conducts two Semester examinations in the same academic year. For further details on pattern of examinations/ assignments/periodicals etc, contact the Coordinator of the courses.
- iv. The appearance at both terminal examinations, evaluation of tutorial, periodicals and practical examination is compulsory.
- v. No students will be allowed to appear in the examinations without the Hall Ticket duly issued by the college and the bona-fide Identity Card.
- vi. Additional Examinations (Re-examination) are conducted either at the first or second term or as applicable on medical ground or for representing college / university in sports, cultural and NSS activities conducted by recognized authorities or any other reason considered valid under exceptional circumstances and to the satisfaction of the Principal. Students are eligible for appearing in additional examinations on producing documentary evidence to this effect. **A STUDENT WHO HAS NOT APPEARED AT BOTH THE TERMINAL EXINATIONS WILL NOT BE ELIGIBLE FOR APPEARING IN THE ADDITIONAL EXAMINATIONS.**
- vii. As per the University of Mumbai rules the college conducts two ATKT examinations for the convenience of the students. **Students are directed to apply for the ATKT examinations in the prescribed format before the due date.**
- viii. The examination rules and regulations are displayed on the Notice Board and announced before the examination begins. Students are directed to follow the instructions given by the Supervisors in the examination hall.
- ix. The unfair means or copy cases in the examinations are dealt with as per the Mumbai University Act 1994 and the provisions of Act no. XXXI/1982 or as the case may be. Students are instructed not to indulge in any kind of unfair practices during examinations. The Unfair Means Committee takes appropriate action against the guilty and prepares the report to this effect.
- x. **RESULTS:** After the completion of the examinations, the faculty of the college gets involved in Centralized Assessment Process (CAP) of answer books, the statistical data of which is then handed over to the **Results Committee**, which does the verification of marks, prepares the mark-sheets and finally results are declared in time.
- xi. **The passing in a subject** is based on the aggregate marks of first and second terminal examinations(marks of additional examinations will be considered if students have appeared for the same in addition to the terminal examinations)
- xii. **Minimum 35% marks in each subject having one paper are compulsory for FY, SY & TYBCom examinations.**
- xiii. In subject having more than one paper, a minimum of 20% in each paper and minimum of 35% in aggregate is compulsory.
- xiv. In case of practical, students are required to secure a minimum of 35% separately
- xv. In case of BCAF and BCBI, students must secure aggregate 40% in each subject out of the total 100 marks, which is divided into 16/40 in Internal Assignments and 24/60 in Theory Examinations.
- xvi. Students may kindly note that Hall Tickets for appearing in the examinations, Mark-Sheets of the results declared and the Forms for Admissions in the SY and TY courses will be issued to none other than the student concern.
- xvii. If, however, students are not in a position to be present for the same, they must submit a **Letter of Authority** with the signature of the person who will do the needful in his/her absence. **The college will not be answerable for any mistake or wrong decision taken by the students in this concern.**

## **LIBRARY RULES**

- i. Library is the warehouse of knowledge and a place for serious study, and hence declared as the silence zone.
- ii. Readers Ticket will be issued to each bona-fide student of the college.
- iii. Student entering library premises must have a valid Identity Card and the Readers Ticket, which is non-transferable. Read and follow the instructions given on the reverse side of the Ticket.
- iv. Only text books and fiction books are issued against this card.
- v. Reference books are for library reference only.
- vi. Students are instructed to read the library rules displayed therein carefully and follow the instructions of the Librarian.
- vii. Students must handle the books and periodicals etc. with utmost care. Any attempt to damage books or periodicals by defacing or tearing the pages will be treated as misconduct and strictly dealt with.
- viii. Loss of Identity Card or Readers Ticket should be reported to the Librarian in writing and a duplicate will be issued on payment of Rs 50/- each.
- ix. In case of late return of books, students will be fined @ Rs 2/- (Rupees two only) per day for the first week and Rs 4/- (Rupees four only) per day. In case of serious defaulters, the late fine will be charged @ Rs.10/- (Rupees ten only) per day.
- x. Students please note that while charging the fine holidays will be counted.
- xi. Book lost by student has to be replaced with a new one in addition to late fine as mentioned above in item no. ix.
- xii. Reissue of the book is subject to availability and demand of the same.
- xiii. Computer facilities are provided to students in a separate cabin within the library premises for project work and internal assignments.
- xiv. Disregard and negligence to these rules will be reported to the Principal for appropriate action against the student concern.

## **CO-CURRICULAR ACTIVITIES**

### **NSS Unit:**

As part of the social responsibility of the college our NSS Unit under the leadership of NSS Officer has been offering commendable service to the society. The NSS students have been regularly involved in various social activities. The college has a very active NSS unit with 100 students registered every year to offer voluntary services for the betterment of the society especially in the villages where they camp for seven days. The NSS students have been involved in organizing varied programmes such as Blood Donation, March Past and Rallies for specific purposes, workshops and orientation programmes, consumer guidance and AIDS awareness etc. The students of our NSS Unit have bagged many prizes in Street Play and awareness programmes at the zonal level.

### **Students Welfare Activities:**

A duly elected Student Council is constituted every year as per the set University norms to look into individual and collective problems of students if any. The General Secretary of the Students Council along with the Assistant Secretary and two Class Representatives (Boy and Girl) from each division work in co-ordination with the Discipline Committee. Though there is no regular PTA meet like schools, parents are often contacted and briefed about their wards' academic performance, behavior and interpersonal relationship among class mates.

### **Placement Cell / Campus Interview:**

The college is committed to provide assistance to our students in the process of making suitable career. The Placement Cell of the college looks into such matters and organizes campus interview for students. We tie up with corporate houses for campus interview and placement of deserving students. The college offers the infrastructure facilities to well-established companies for recruitment drive within the premises of the college. This year our students were selected by eminent companies like Wipro, Max New York Life and others that came for recruitment drive in the campus; and were offered the appointment letters on the spot after thorough process of selection.

## **Sports / Culture:**

The College regularly conducts sports activities under the expert guidance of our Sports Coordinator. Annual sports competitions are held and best sports person is declared every year.
